THE MEASURES:

Axis 3 (Rural Life) has 6 Measures:

- 3.1 Diversification into Non – Agricultural Activities
- 3.2 Business Creation and Development
- 3.3 Encouragement of Tourism Activities
- 3.4 Basic Services for the Economy and Rural Population
- 3.5 Village Renewal and Development
- 3.6 Conservation and Upgrading of the Rural Heritage

WHAT TYPE OF GRANTS ARE AVAILABLE?

Maximum grant per PRIVATE SECTOR applicant is £50,000
Grant-aid @ 50% eligible costs

Maximum grant per SOCIAL ECONOMY / NON DEPARTMENTAL PUBLIC BODIES / COMMUNITY APPLICANTS is £50,000 but for more strategic projects - £50,000 - £250,000
Grant-aid @ 75% eligible costs

25% contribution can be 20% In Kind but must have at least a 5% cash contribution

Examples of Ineligible Activities:

(Please note that this is not an exhaustive list)

- Service or distribution businesses, unless they are innovative in your area
- Projects that have already started
- Projects where there is a clear statutory responsibility
- Projects that create economic displacement
- Projects that have negative environmental impacts
- Mainstream agricultural/horticultural activities
- Annual or recurring events (the programme can only consider new events)
- Mobile infrastructure (except specialised infrastructure for specific projects)
- Private dwellings

HOW IS YOUR APPLICATION ASSESSED?

All project applications will be assessed by Lagan Rural Partnership's Local Action Group (LAG) and Joint Committee (JC) on a competitive basis. The LAG and Joint Committee members are detailed overleaf.

Also enclosed is a flow diagram detailing the journey of your application. This diagram explains the role of our staff, the Local Action Group and the Joint Committee in the assessment of your application.

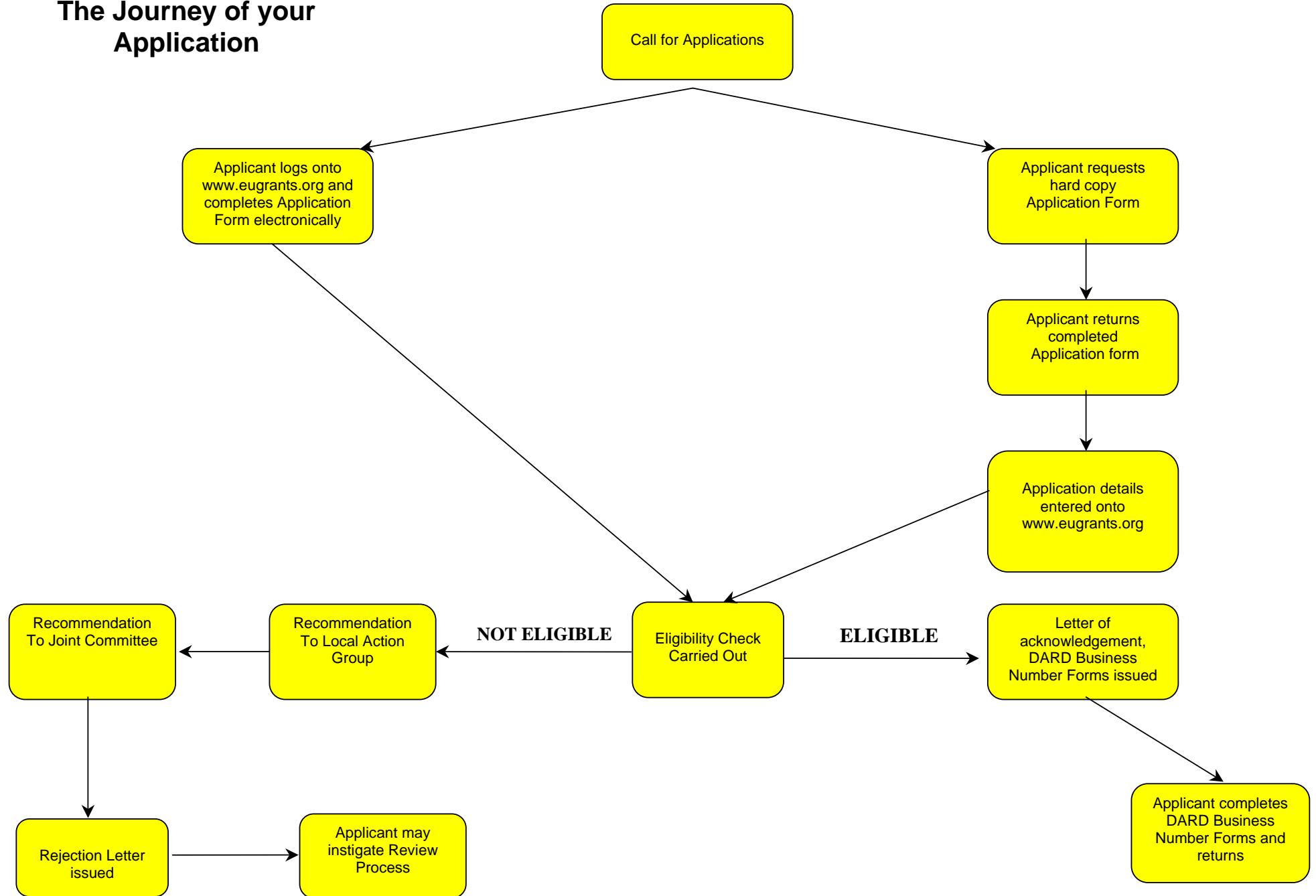

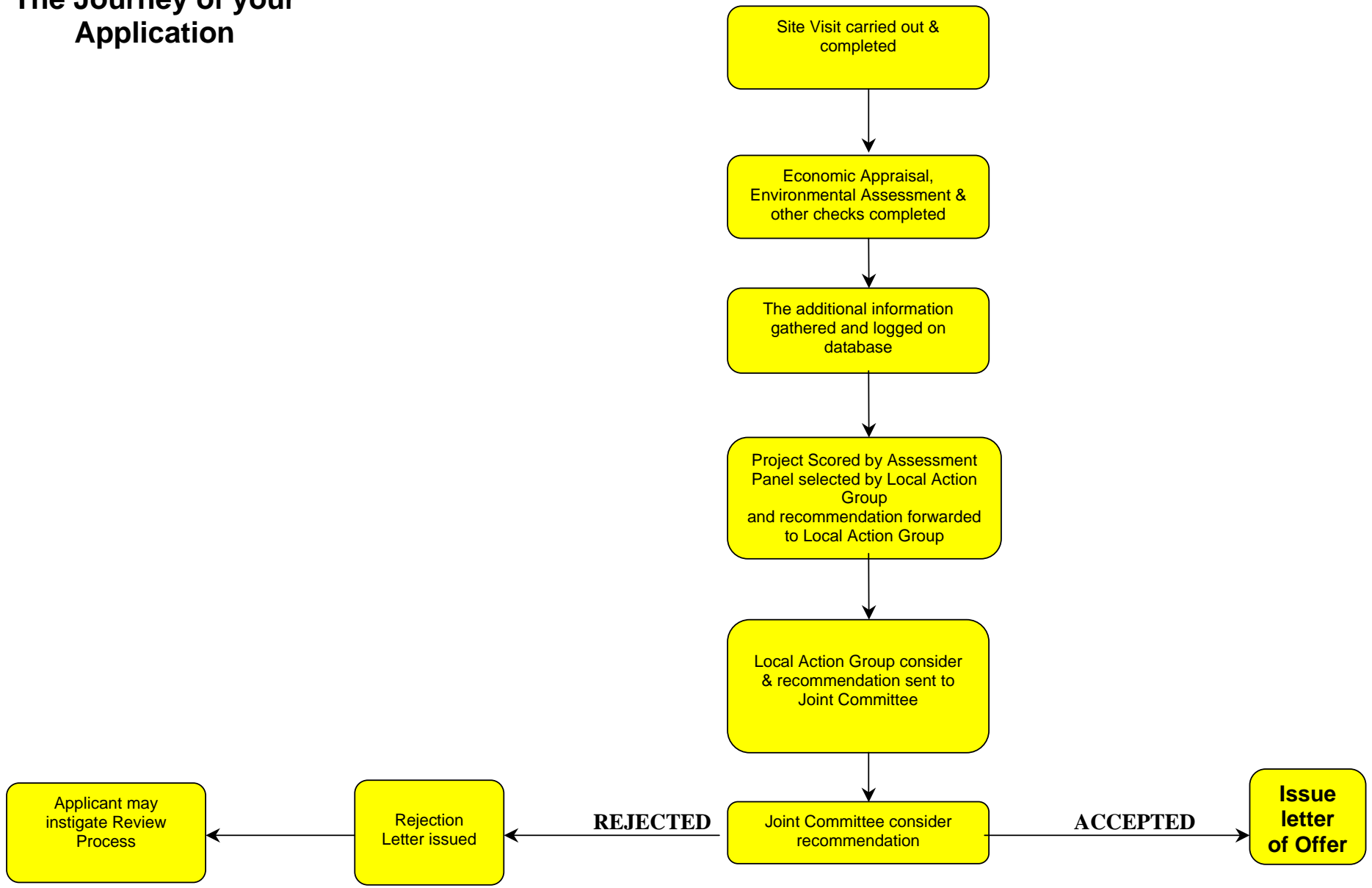

Measure 3.1 Diversification into Non – Agricultural Activities

Open: Monday 12 October 2009
Close: Friday 4 December 2009 at 5.00 pm

What will this Measure do?

This Measure will provide support to members of farm households who wish to diversify into non-agricultural activities (project must be based on the farm – projects based off-farm are ineligible under this Measure but may be eligible under other Measures).

Why?

In order to maintain or increase the income of the farm households and create employment opportunities.

Who can benefit?

By members of a farm household we mean any member of the farm household who derives benefit from the farm or who contributes to the household income.

Please note: This is a competitive programme.

What type of projects can be supported?

Here are a few of the activities that might be supported under this Measure

- Light engineering
- Innovative services
- Traditional skills
- Equestrian services
- Crafts
- Recycling facilities
- Renewable energy initiatives (only as part of a larger project)

Please note: See further details of eligibility overleaf.

What type of grant and how much?

Activity	Level of support	Maximum Grant
1. Technical support for business plans or feasibility studies to help new businesses become established and to help existing businesses consolidate and expand	Up to 50%	Up to £5,000.
2. Bespoke training, directly related to individual project applications, which is not on offer from any other provider	Up to 50%	Up to £5,000.
3. Marketing support	Up to 50%	Up to £5,000
4. Grant-aid towards capital and resource costs (large grant)	Up to 50%	Up to £50,000

Applications may be made for a capital grant and one (or more) of the other 3 support elements on the same application. Under this scenario maximum funding available can increase to £55K

Eligible Applicants

Farm owner or members of a farm family who have written permission to carry out the diversification activities from the registered holder of the DARD farm business reference number and that you currently carry out an agricultural activity on the farm.

Measure 3.2 Business Creation and Development

Open: Monday 12 October 2009

Close: Friday 4 December 2009 at 5.00 pm

What will this Measure do?

This Measure will provide support to existing micro-enterprises or social economy businesses or to persons or groups wishing to set up a new micro-enterprise. Please note that this Measure is not applicable to businesses which will be based on-farm.

Why?

To create employment opportunities and develop economic infrastructure in rural areas.

Who can benefit?

Existing micro-enterprises and social economy businesses (not more than 10 employees). Persons wishing to set up a new micro-enterprise or social economy enterprise. **Please note: This is a competitive programme.**

What type of projects can be supported?

Activities could be similar to those funded via the Northern Ireland LEADER+ Programme. Types of projects that might be supported under this Measure could include:

- Day-care facilities
- Traditional skills
- Innovative manufacturing businesses
- Light engineering

Please note: See further details of eligibility overleaf.

What type of grant and how much?

Activity	Level of support	Maximum Grant
1. Technical support for business plans or feasibility studies to help new businesses become established and to help existing businesses consolidate and expand	For all of these grants the level of support is up to 50% for the private sector and 75% for social economy enterprises including Community Groups.	Up to £5,000.
2. Bespoke training, directly related to individual project applications, which is not on offer from any other provider		Up to £5,000.
3. Marketing support		Up to £5,000
4. Grant-aid towards capital and resource costs (large grant)		Up to £50,000

- **Social economy enterprises may provide match funding in the form of contribution in kind (20%) and cash contribution of at least 5%**
- **Applications may be made for a capital grant and one (or more) of the other 3 support elements on the same application. Under this scenario maximum funding available can increase to £55K**

Eligible Applicants

Applicants must be located in a rural area and have less than 10 employees (FTE – Full Time Equivalents) and an annual turnover of less than euros 2 million. These limits apply to individual or linked companies.

They may be:

- private individuals, aged over 18 years
- private companies or partnerships
- social economy enterprises*.

Definition: Social Economy Enterprise* (SEE) are viewed as those organisations that have a social, community or ethical purpose, operate using a commercial business model and have a legal form appropriate to a not-for personal profit status.

This measure will not provide support for applicants eligible under measures 3.1 and 3.3

Measure 3.3 Encouragement of Tourism Activities

Open: Monday 12 October 2009

Close: Friday 4 December 2009 at 5.00 pm

What will this Measure do?

This Measure offers new and existing tourism providers an opportunity to develop, promote or expand tourism activities and infrastructure.

Why?

- To improve the marketing, co-ordination and promotion of tourism activities,
- To increase visitor numbers to the region,
- To create employment opportunities and
- To encourage sustainable, eco-friendly tourism developments

Who can benefit?

Private sector and social economy tourism businesses and public bodies that have a tourism remit. **Please note: This is a competitive programme.**

What type of projects can be supported?

New and existing tourism products can be supported under this measure e.g.

- Activity based tourism
- Self-catering accommodation

What type of grant and how much?

Measure 3.4 Basic Services for the Economy & Rural Population

Open: Monday 12 October 2009

What will this Measure do?

This Measure offers new and existing businesses/organisations/groups an opportunity to develop, promote or expand basic rural services. This programme offers service providers and communities an opportunity to develop innovative, tailor made solutions that meet service provision needs at a local level.

Why?

To improve the access to and provision of rural services.

Who can benefit?

Applications are invited from the private sector, social economy sector, public bodies and community-based (not for profit) organisations

Please note: This is a competitive programme.

What type of projects can be supported?

- Outreach work providing access to a wide range of services (health & well being; education; benefits; jobs; financial and debt counselling)
- 'Door-step' delivery of a range of services
- Sharing of equipment and premises in order to deliver value for money services

What type of grant and how much?

Who can benefit?

Applications are invited from the private sector, public bodies, social economy sector and community-based organisations.

Please note: This is a competitive programme.

What type of projects can be supported?

- Village Action Plans
- Streetscape improvements & Aesthetic improvements
- Promoting greater community inclusiveness/participation
- Greater use of existing buildings

Measure 3.6 Conservation and Upgrading of Rural Heritage

Open: Monday 12 October 2009

Close: Friday 4 December 2009 at 5.00 pm

What will this Measure do?

This Measure offers new and existing businesses/organisations/groups an opportunity to develop, promote and implement projects to preserve and upgrade rural heritage and to use the natural and built environment as the basis for sustainable economic growth in rural areas.

Why?

The diversity of natural and cultural resources, if properly nurtured and their use carefully encouraged, represent considerable economic potential for a confident and distinct rural Northern Ireland. To assist and encourage an increased knowledge and/or access to rural heritage sites, stewardship of environmental resources and localised heritage, culture and history projects.

Who can benefit?

Applications are invited from the private sector, social economy sector, public bodies and community-based organisations.

Please note: This is a competitive programme.

What type of projects can be supported?

- Monument/heritage site conservation and protection
- Access/signage/information re heritage sites
- Culture, history and heritage
